Den Braven Clamp is a versatile and efficient single handed clamp. The pistol grip handle houses a ratchet clamping mechanism that incrementally applies force when the trigger is pulled. The new Easiclamps and Powerclamps can be used as a bar clamp or as a spreader simply by turning the handle around.

##### Directions Of Use

**Single Handed Repeatedly** squeeze the trigger until the jaws clamp on to the object being held. **Double Handed (High Speed Operation)** Hold the handle in one hand and with the other push down on rod until contact is made with the object. Squeeze the trigger to exert desired clamping force. **Release of Clamping Force** To release or reposition the clamp jaw, squeeze the quick release trigger located in the handle. The clamping jaws are forced apart allowing the jaw to slide along the bar.
