Intensely shake the canister and spray the Plastic Cleaner evenly at the surface. Let the Plastic Cleaner soak for several minutes to loosening and absorb the dirt. Use a dry cloth to remove in one direction the Plastic Cleaner and dirt. Allow the surface to dry and polish the treated surface if needed with a dry cloth.
