Directions Of Use

Ensure the battery is not attached. Prepare the cartridge by holding the cartridge firmly against the hard surface and with a sharp blade holding away from your body cut the sealing cap off the cartridge. Firmly screw the cartridge nozzle onto the cartridge. Push the plunger release button and pull the rod as far back as you can. Insert the cartridge with the nozzle facing away. Cut the front of the nozzle at a 45-degree angle to adjust the thickness of applied sealant. Re-insert the battery. Push the trigger to start to apply the sealant. By turning the rear wheel applicator, you can adjust the speed to control the output flow of adhesive or sealant.
